Camellia plc ('Camellia or the 'Company') announces that, in accordance with the terms of its share buyback programme announced and commenced on 6 December 2024 (the "Share Buyback Programme"), the Company purchased the following number of its ordinary shares of £0.10 each through Panmure Liberum Limited.

The Company will cancel the repurchased shares. Following the purchase and cancellation of these shares, the remaining number of ordinary shares in issue will be 2,818,474. The Company holds 62,500 ordinary shares in treasury therefore, the total voting rights in Camellia will be 2,755,974. This figure for the total number of voting rights may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
